



2024 Gold Country Fair Livestock Exhibitor Checklist

Directions: Entries are due via **ShoWorks Online entry system**. The other items listed below are due via email submission to entries@goldcountryfair.com by **Thursday, August 1, 2024**, by midnight. **NO exceptions.**

1. **Entries:** ALL entries (Livestock & Still) are due Thursday, August 1, 2024. You are required to enter online through our **ShoWorks Online entry system**:

 - b. ALL livestock exhibitors are **required** to submit one Still Exhibit.
 - c. Please carefully review all entries, prior to submission.
2. **Adult Code of Conduct:** A.C.C. can be found on Page 18 of the Livestock Exhibitor Handbook. Please include this fully executed contract in this email.
3. **YQCA Certificate:** (Youth for the Quality Care of Animals): You can complete the YQCA course and obtain the certificate <http://yqcaprogram.org/>. Please include your certificate of completion in this email. Entry forms will **NOT** be accepted if training is not completed.
4. **Bill of Sale:** For livestock entered in Placer County Bred & Fed divisions, a Bill of Sale from the breeder is **required**. **If you bred and fed your own stock, a self-declaration is still required.**

Additional Department Specific Expectations:

- Junior Swine Department

CA Prop 12 Update: Proposition 12 paperwork is not required for the 2024 Gold Country Fair. If your hog is Prop 12 certified, please provide a copy of the certification by August 1, 2024, for recognition on the Junior Livestock Auction sale catalog.

- Junior Beef Department

State of California Bill of Sale or Consignment: A Brand Inspection or an out billing from an auction yard must be made out to the exhibitor, showing proof of 150 days ownership, or a signed statement declaring the animal was bred and raised by the exhibitor.

Market Beef exhibitors must furnish a yellow *State of California Bill of Sale or Consignment*. The original copy will be collected and provided for the State Brand Inspector on Wednesday, September 4th, 2024, at 6 pm.

FAILURE TO SUBMIT ENTRIES ONLINE VIA SHOWWORKS & THESE ITEMS VIA EMAIL BY Thursday, August 1, 2024, by midnight WILL RESULT IN INELIGIBILITY TO SHOW/SELL AT THE 2024 GOLD COUNTRY FAIR. NO EXCEPTIONS.
