All entries will only be accepted via the **ShoWorks Online** entry system until **Thursday, August 1, 2024**. (please reference each department to specify each livestock's information)

### Credentials, Passes, and Admission

Each livestock exhibitor will be given one 4-day admission wristband and one Livestock Parking Pass to the Gold Country Fair. Wristbands will be available to pick up on Wednesday from 8 AM – 8 PM during the Livestock Exhibitor Check-In. At this time, you may purchase additional 4-day admission wristbands for \$20 each or 1-day admission pass for \$5 each. Additional passes are available for purchase for parents/family members of livestock exhibitors, FFA/4-H Instructors, and Senior Leaders. Wristbands **must** be worn during the entirety of the fair.

### Carnival Bonus

Before fair time begins, livestock exhibitors may purchase a 1-day Unlimited Carnival Rides wristband for \$30. This wristband is good for all open hours of the fair (day of purchase), Thursday through Sunday. These may be purchased prior to the opening day of fair. The price of a carnival wristband will go up to \$37 at the fair.

### Still Exhibit Entry

All livestock exhibitors are required to enter at least one entry into the Still Exhibit Department. Entries are due by **Thursday, August 1, 2024**, by 11:59 PM. Entries are free for all youth 18 and under. The age limit is 19 and under if an exhibitor is a 4-H/FFA member.

# Online Entry Information



## Entry Form Method

### How can I enter?

At the beginning of each department page is the information relative to that competition. This information includes eligibility requirements, entry deadline, delivery/pickup information and judging schedule.

### When is the entry deadline?

Online entries and fees must be received online through [ShoWorks](#) by 11:59 PM on **Thursday, August 1, 2024**. Entries that are not complete by August 1, 2024, will be charged a \$25 penalty fee per entry. The required information and penalty fee must be submitted by August 8, 2024, in order to participate at fair.

### Where do I submit my entries and fees?

You are required to enter online through our [ShoWorks Online](#) entry system.

All entries must be submitted online before the deadline. **No** paper entries will be accepted.

## ShoWorks

1. Click 'Sign-In' in the top right corner.
2. Use the drop-down box for 'I am a..' and choose 'Exhibitor'
3. Sign-in if you have previously used ShoWorks Software for other fairs, expositions, and/or jackpots.
4. OR, if you do not have an existing account, click 'I am a new exhibitor or have yet to register this year.'
5. Complete the following page of exhibitor information.

7. You will select 'Department' then 'Division' and then 'Class'
8. Fill in the required information for each entry.
9. **Review** your entries, pay, and confirm. Make sure you have completed all steps to ensure your entries were successfully completed.

# New to 2024!

Please see below for some of the new updates for the 2024 Junior Livestock Department. The significant updates are listed below as a quick point of information for planning purposes.

## ✓ **SHOW SCHEDULE**

- Review the Show Schedule for changes and updates.

## ✓ **PRIMARY PYGMY GOAT & JR. DAIRY EXHIBITORS**

- **Primary** pygmy goat **and** Jr. Dairy Goat exhibitors will have the option to occupy a stall for the duration of the Gold Country Fair **or** bring their goats before the show and take them home following the show. Exhibitors are responsible for bringing their own water bucket/equipment for the duration of the show.
  - Exhibitor must declare which option they chose on entry. Stall chart will not reserve exhibitor a stall if not declared.

## ✓ **SMALL ANIMAL BARN**

- Shavings are required in all small animal cages. 'Pee Pads' will not be permitted.
  - Please dispose of shavings in the correct container.

## ✓ **RESALE MARKET HOGS - CA PROPOSITION 12 COMPLIANCE STANDARD**

- Hogs will **not** be allowed to be sold for resale in the 2024 Gold Country Fair Junior Livestock Auction. As such, Exhibitors do not need to provide the Proposition 12 breeder compliance paperwork for the 2024 Gold Country Fair. Buyers must be prepared to purchase market steers as a custom purchase or donate the purchase.

## ✓ **RESALE MARKET STEERS**

- Market steers will **not** be sold for resale in the 2024 Gold Country Fair Junior Livestock Auction. Buyers must be prepared to purchase market steers as a custom purchase or donate the purchase.

## ✓ **MARKET GOAT PAY WEIGHT**

- Market goat pay weight increased from 105 lbs. to 110 lbs. Goats weighing more than 110 lbs. will sell at 110 lbs.

# Pre-Weigh In Rules

**Beef Pre-Weigh In:** Saturday, April 6<sup>th</sup>, 2024 – 8:00 AM – 10:00 AM

**Lamb/Goat/Swine Pre-Weigh In:** Saturday, June 29<sup>th</sup>, 2024 – 6:30 AM – 10:00 AM

1. All sale animals, except for poultry and rabbits, must have been pre-weighed (replacement animals **are** required to weigh in and must be tagged and must be declared as a replacement animal at the time of pre-weigh in) and ear tagged at the designated pre-weigh in dates. Pictures may be taken at time of weigh in with ear tags in the animal ears.
2. An official Gold Country Fair ear tag/tattoo is required on all market animals from the time of weigh-in to the release of animals. At pre-weigh ins, all other identification tags will be removed at the scales (with exception of Jr. Grand National CYAE or California State Fair ear tags and scrapie tags.)
3. An exhibitor is only allowed to pre-weigh in (2) two **large** market animals per species, at pre-weigh in OR exhibitor may choose to weigh in (1) one market animal and (1) one Family Back-Up Animal.
  - a. Family Back Up Animal Definition: A family back-up animal can only be used by an immediate family member by marriage, birth, or adoption. The family member (exhibitor) using the family back up, must declare it, properly enter it, and pay the appropriate entry fee prior to the entry deadline. Only one family member (exhibitor) is eligible to enter and exhibit the animal.
  - b. All family back-up animals are required to pre-weigh in and declared as a family back-up at the time of pre-weigh in.
4. Feeder animals do NOT have to pre-weigh in. They are REQUIRED to weigh in on Wednesday, September 4, 2024, from 6:00 pm – 8:00 pm.
5. Animals must be owned and cared for by the exhibitor for the following minimum length of time prior to the Gold Country Fair:

Beef	150 days
Lambs, Swine & Goats	60 days
Small Animals	30 days
6. No early or late pre-weigh ins are permitted. If you are unable to attend the designated pre-weigh in, you must call the Gold Country Fairgrounds office at least 30 days before the pre-weigh in.
7. Official Weighmasters will be provided. No Pre-Weighing of animals is permitted. If a weight is contested, re-weigh must be requested at the scale immediately. The animal in question will be removed from the scale, the scale will be re-balanced, and the animal will again be weighed. Under no circumstances shall the animal leave the scale area.
8. There are to be no private scales on the grounds. Excessive exercise of a market animal for the purpose of weight reduction is forbidden on the Fairgrounds. Excessively wet animals will be disqualified by the Weigh Master.
9. Sheep Tail Docking - To qualify for exhibit after December 31, 2002, market lambs must be docked such that the tail (dock) is healed and can be lifted from the exterior. Lambs that have no dock will not be eligible.
10. Any foul, abusive language and/or physical abuse used toward any Fair Personnel, Weigh Master, Auction Committee Member, Judge, etc. by exhibitors or parents may result in the immediate expulsion of the violators and their animals from the Fairgrounds for the duration of the Fair. This is a ZERO TOLERANCE policy.

# Weigh In Rules

**Required Weigh In:** Wednesday, September 4, 2024 – starting at 6:00 PM

1. Livestock Exhibitors are required to check in and pick up credentials at the Livestock Office any time from 8:00 AM – 8:00 PM on Wednesday, September 4, 2024. Exhibitors who fail to check in on Wednesday will be considered scratched from fair, even if livestock are weighed in.
2. Livestock Consignment Agreement will be issued to each exhibitor at Exhibitor Check-Ins on Wednesday, September 4, 2024, from 8:00 AM – 8:00 PM. **Livestock exhibitors are responsible for submitting this agreement to the Livestock Office 30 minutes after your market class.** Failure to submit this agreement will result in **disqualification** from the sale. **NO** exceptions.
3. The Gold Country Fair requires exhibitors of all market and replacement animals to complete a Medication Declaration Form for each animal brought to the scale for official weigh-in.
4. No one is to be in the scale area except for Exhibitor, Animal, Fair Staff, and designated weigh-helper during weigh-in.
5. All sheep and goats entering fairs require individual official scrapie identification issued by the USDA. Individual identification must be kept on the animals.
6. Market lambs must be slick shorn within 10 days of the opening day of the Fair.
7. Market Beef Exhibitors must furnish a Bill of Sale and/or official Brand Inspection form to the State Brand Inspector and provide a copy with entries. A Brand Inspection or an out billing from an auction yard must be made out to the exhibitor, showing proof of 150 days ownership, or a signed statement declaring the animal was bred and raised by the exhibitor.
8. Weighmasters will be provided. No Pre-Weighing of animals is permitted (before official designated pre-weigh in date).
9. If a weight is contested, re-weigh must be requested at the scale immediately. The animal in question will be removed from the scale, the scale will be re-balanced, and the animal will again be weighed.
10. Under no circumstances shall the animal leave the scale area. Underweight market animals entered in a market class will automatically be enrolled to a feeder class, overweight feeder animals may NOT move up to a market class.
  - a. Two (2) feeder entries per specie, is allowed per exhibitor.
11. If an animal does not make weight, no replacements are allowed.
12. All scales used for official weigh in have been certified by Placer County Department of Weights and Measures. There is no recertification of scales allowed.
13. There are to be no private scales on the grounds. Excessive exercise of a market animal for the purpose of weight reduction is forbidden on the Fairgrounds. Excessively wet animals will be disqualified.
14. Any foul, abusive language and/or physical abuse used toward any Fair Personnel, Weigh Master, Auction Committee Member, Judge, etc. by exhibitors or parents may result in the immediate expulsion of the violators and their animals from the Fairgrounds for the duration of the Fair. This is a ZERO TOLERANCE policy.

# Show Week Rules

**Show Days:** Wednesday – Friday

1. Exhibitors must care for their animals until departure from the Fairgrounds or they will forfeit all awards, auction monies and eligibility at future Gold Country Fairs. There is zero tolerance in regard to exhibitor and parent conduct. This includes mucking stalls and always maintaining a clean stall and aisle.
2. All animals eligible for the sale must be shown as individuals in their respective classes and will be selected at the judge's discretion. Animals will be placed in Sale Order by official show clerks based upon the judge's direction.
3. A minimum of five entries per division must be judged in order for a Champion and Reserve Champion to be awarded.
4. Condition of Sale Animals: Only natural colored paint is to be allowed (beef). No other paint or decorations on animals is allowed. All sale animals must be in show-groom condition when entering the sale ring, or the animal will be disqualified from the Junior Livestock Auction.
5. No artificial hair-like substance or coloring changes will be permitted. No icing, slapping, drenching or muzzling will be permitted. All animals are subject to inspection by the official Fair veterinarian at all times. All animals will be inspected prior to entering the ring.
6. Junior exhibitors are expected to groom and care for their own animal(s) when at the Fair. They shall refrain from accepting active assistance from anyone. Failure to comply will result in disqualification of the exhibits as well as the exhibitor. NO professional fitters allowed.
7. All exhibitors of sale animals must be present in the official uniform when photo is taken for buyer's photographs. Photographs are required to be taken immediately after the conclusion of your market class. **This photo is a requirement for the sale of the animal. NO late photos will be permitted.**

# Junior Livestock Auctions Rules

## Junior Livestock Auction: Saturday

1. Livestock Consignment Agreement will be issued to each exhibitor at Exhibitor Check-Ins on Wednesday, September 4, 2024 from 8:00 AM – 8:00 PM. **Livestock exhibitors are responsible for submitting this agreement to the Livestock Office 30 minutes after your market class.** Failure to submit this agreement will result in **disqualification** from the sale. **NO** exceptions.
2. The Gold Country Fair Junior Livestock Auction is a terminal sale for animals, except Replacement Heifers, Ewes, Gilts, and Does.
3. Seven percent (7%) commission will be charged for each sale. Three percent (3%) commission will be charged for all add-ons. The commission fee will be placed in a Junior Livestock Auction Fund for promotion expenses and Auction Contingency Fund.
4. Primary members are not eligible to sell.
5. All Champions and Reserves must sell. Only in the instance that an exhibitor is awarded both a Champion and/or a Reserve Champion will an exhibitor be allowed to sell more than 1 animal.
6. The Limit of one (1) market entry to be sold through the Junior Livestock Auction has the following Pen exceptions. Rabbits: one entry consists of three (3) Rabbits. Poultry: one entry consist of (2) Ducks or (2) Chickens.
7. No junior exhibitor may exhibit a market animal which has been sold through a Fair Junior Livestock Auction whether or not there is an actual change of ownership.
8. Only animals deemed worthy by the judge and declared market ready/acceptable will be allowed to sell in the Junior Livestock Auction.
9. If an exhibitor enters more than one small animal market entry in the same species, the highest placed entry will sell.
10. Condition of Sale Animals: Only natural colored paint is to be allowed (beef). No other paint or decorations on animals is allowed. All sale animals must be in show-groom condition when entering the sale ring, or the animal will be disqualified from the Junior Livestock Auction.
11. No artificial hair-like substance or coloring changes will be permitted. No icing, slapping, drenching or muzzling will be permitted. All animals are subject to inspection by the official Fair veterinarian at all times. All animals will be inspected prior to entering the ring.
12. All animals eligible for the sale must be shown as individuals in their respective classes and will be selected at the judge's discretion. Animals will be placed in sale order by official show clerks based upon the judge's direction.
13. Each exhibitor will be allowed to sell only one (1) market entry regardless of species: One (1) Market Beef or one (1) Replacement Heifer, or one (1) Market Hog or one (1) Replacement Gilt, or one (1) Market Lamb or one (1) Replacement Ewe, or one (1) Market Goat or one (1) Replacement Doe, or one (1) pen of Rabbits or one (1) Single Fryer Rabbit, One (1) dozen Market Eggs. Exhibitor must decide/declare which eligible animal to sell and submit a consignment form to the Livestock Office within 30 minutes of the conclusion of the show.
14. The Sale Order will be posted at the Livestock Entry Office. It is the exhibitor's responsibility to check this list immediately upon posting and report any changes to the Livestock Entry Office. Corrections must be made at the time posted by the Livestock Entry Office. You will have one hour after it's posted to find any mistakes. After that, once mistakes are fixed, the sale order will be FINAL.
15. Sale Order for the 2024 Junior Livestock Auction will be done on a rotational basis and will be determined by

the Junior Livestock Auction Sub-Committee. The 2024 sale order is as follows: Lambs, Turkeys, Goats, Eggs, Meat Birds (Pens and Single), Ducks, Beef, Rabbits (Pens and Single), Swine, Replacement, Repeat. Champions will sell at the beginning of each species. Species must have 10 animals to split in the sale order.

16. All Small Animals and replacements will be sold by the lot, not by the pound, with the exception of turkeys.
17. Any marking of sale animals required by Fairs & Expositions will be enforced.
18. PAY WEIGHT LIMITS. There will be no top weights on the following species, and the top pay weights for sale purposes are as follows:
  - Beef = 1,400 lbs.
  - Sheep = 150 lbs.
  - Goats = 110 lbs.
19. Maximum weight for all market hogs is 300 lbs. Minimum Weight is 220 lbs. Hogs weighing above 300 lbs. will be disqualified from market classes and the Junior Livestock Auction but may remain in Showmanship (State Rule VII, 30).
20. A substitute handler to sell the animal will be allowed only after approval from Gold Country Fair Management. The exhibitor must present to Fair Management a written request to have another eligible exhibitor sell their animal. The substitute exhibitor must appear in full uniform of his/her respective organization (4-H, FFA or Grange). This request must be provided to management 10 days prior to auction day.
21. Exhibitor must enter the auction block without additional handlers, (with the exception of one additional exhibitor in a uniform to hold a champion banner).
22. Exhibitors will not be allowed to ask the person who buys their animal to give or sell it back to the exhibitor. Exhibitors may not offer to trade another animal that was not sold in the auction to the buyer for the sale animal.
23. The Junior Livestock Auction Sub-Committee is responsible for shipping of all large sale animals.
24. All animals sold in the auction must go to the designated processing plant as determined by the Junior Livestock Auction Sub-Committee. Market steers and Market Lambs will go to the designated processing plant to be eligible for the carcass contest. The Junior Livestock Auction is a Terminal Sale for all Market Animals with the exception of Replacement Females.
25. Sellers of market lambs and market goats are financially responsible for animals which are rejected at the processing center due to the presence of scrapie.
26. Checks for the sale of animals will be available at the Gold Country Fair Administration Office beginning **Monday, October 7, 2024**, between the hours of 8:00 AM to 5:00 PM, Monday through Friday. Exhibitors must present a "Thank You" letter for their buyer and each add on, to the Fair office, in a stamped, sealed envelope.
27. In the event that an exhibitor receives an overpayment in premium or sale monies, the exhibitor is responsible for returning the overpayment to the Gold Country Fair. Failure to do so may result in forfeiture of eligibility at future Gold Country Fairs.
28. Failure to observe the Junior Livestock Auction Rules may result in the animal being excluded from the sale.

# General Rules

1. All entries due online only by midnight on August 1. The Gold Country Fair is not responsible for technical or website issues.
2. Jr. Exhibitors are required to conform to written State/Local rules and/or instructions.
3. Entries in the 4-H Department are restricted to bona fide members of a Placer County 4-H Club. Entries in the FFA Department are restricted to FFA members enrolled in Placer County FFA Chapters. Entries in Grange Departments are restricted to youth Grange members enrolled in Placer County Granges. Independent exhibitors MUST reside in Placer County.
4. NOTICE: Entries in 4-H, FFA, Independent and Grange divisions is restricted to residents of Placer County. Exhibitors whose club or chapter is in Placer County but who do not reside in Placer County must submit a letter requesting a waiver from this requirement to Gold Country Fair Management. The letter should explain the exhibitor's reason for enrollment in an organization outside of their county of residency. In the case of livestock projects, the letter must also state the exhibitor's guarantee that they intend to sell market animals at Placer County and/or Gold Country Fairs exclusively (the only exception is to sell a market animal at Jr. Grand National).
5. 4-H members: A bona fide 4-H member is a youth five (5) years old or in kindergarten by January 1, of the year of the fair, to exhibit as a Primary member. Primary members are eligible to enter primary classes only. Primary members are not eligible to show large livestock or sell in the Livestock Auction. Jr., Intermediate and Sr. 4-H members must be nine (9) years old or in the 4th grade by January 1, of the year of the fair. Exhibitors are eligible to compete/exhibit through December 31 of the year they turn 19 years of age. Any questions as to eligibility rest with the Placer County 4-H Leader's Executive Committee.
6. FFA members may participate in classes when they enroll in high school vocational agricultural classes and may exhibit as members to the end of the calendar year following graduation.
7. Grange members may exhibit if they are at least 5 years of age by January 1, of the year of the fair and until the end of the calendar year in which the member reaches age 19. Grange members ages 5 through 9 are subject to the same rules as 4-H Primary members.
8. Independent Exhibitors must be at least 9 years old or in the 4th grade by January 1, of the year of the fair. Exhibitors are eligible to compete/exhibit through December 31st of the year in which they turn 19 years of age. Independent Jr. exhibitors must enter an open Jr. class unless one is not available. If an open Jr. class is not available, Jr. exhibitors may enter an appropriate FFA or 4-H class if they meet all appropriate FFA and/or 4-H age/grade, and State Rules requirements. Jr's who have been FFA, 4-H or Grange project members within 60 days prior to the Fair are not eligible to compete in that project as independent Jr's (150 days for market beef). Each entry in these divisions shall have been made or produced by the exhibitor. Entries shall be made on Jr. Department entry forms provided by the Fair. The signature of a parent or guardian is required. State and Local Rules apply to all entries and scorecards in corresponding Sr. and Jr. Department classes shall be used unless otherwise provided in these divisions.
9. ALL 4-H exhibitors, FFA exhibitors and independent exhibitors MUST have completed mandatory YQCA Quality Assurance Training. Entry forms will not be accepted if training is not completed. All 4-H Leaders, FFA Advisors and Parents and/or Guardians of 4-H, FFA, and Independent Exhibitors must abide by all rules and regulations of the 4-H and FFA standards in the Exhibitor's Handbook including Quality Assurance/Ethics Training rules and regulations. Visit YQCA .org to complete the training.
10. All Independent Exhibitors are required to show proof of liability insurance. County, District, and State Fairs cannot legally carry liability insurance covering Jr. exhibitors and/or their exhibits.

# General Rules

Obtaining liability insurance is the responsibility and at the discretion of the Jr. exhibitors. A policy may be purchased by all exhibitors from California Fairs Service Authority (through the fair office) at a minimal cost.

11. **FFA:** The official FFA Show Uniform shall be worn by all FFA exhibitors and by helpers in individual and chapter groups while showing at the Gold Country Fair. The official FFA Show Uniform shall consist of the following: white pants, white shirt with FFA emblem attached to left pocket, FFA tie, clean shoes or boots, cuffs to be worn over boots, FFA jacket; no hats or head gear of any kind.  
**4-H:** Every 4-H exhibitor of livestock must wear the official uniform of his or her organization while showing his or her animals. The following 4-H uniform specifications must be followed: **Boys:** 4-H cap; 4-H tie or scarf; white shirt, short sleeve, or long sleeve, buttoned at wrist; white or logan green pants with belt when belt loops are provided; shoes or boots are required; boots, if worn, should be inside pants leg.  
**Girls:** 4-H cap; white blouse and white skirt or white dress of comparable design; or white or logan green pants with belt when belt loops are provided, green 4-H scarf with 4-H emblem on back corners, with a fastener or 4-H tie; shoes or boots are required; boots, if worn should be inside pants leg.  
**Independents:** Must wear whites during the competition. "Whites" shall consist of new-appearing, white trousers or skirt and a new-appearing, white blouse or shirt. Hats are not acceptable. Open-toed footwear, shorts, tee shirts, sleeveless shirts or clothing with any artwork or embroidery are not acceptable. Any exhibitors not conforming to these qualifications will be disqualified from the class.
12. The rules and regulations prescribed for the Jr. Department have been formulated with the cooperation and approval of state leaders of Jr. groups.
13. Representatives and leaders of the Jr. groups should consult with the Fair Management in preparing the Exhibitor Handbook for the Jr. Department. The divisions and classes to be included in the Exhibitor Handbook should be selected so as to provide the maximum of competition in order that the greatest benefits of the program of education by comparison with established standards may be achieved.
14. Jr. exhibitors are required to conform to written State and Local Rules and/or instructions. Failure to comply with the rules, or damage to the Fair and/or other exhibitors' property will result in loss of premium awards and expulsion from the Fairgrounds.
15. Entries in Showmanship and the 4-H Department are restricted to bona fide members of the Placer County 4-H Club. Entries in the FFA Department are restricted to FFA members enrolled in Placer County FFA Chapters. Entries in Grange Departments are restricted to youth Grange members enrolled in Placer County Granges. Independent Jr. exhibitors not affiliated with any organization can enter appropriate FFA or 4-H classes if they meet the age or grade level requirements and reside in Placer County.
16. If the owner or co-owner of livestock or other exhibits used or housed outside Placer County is a bona fide resident of Placer County, then such livestock or other exhibits in which they have a financial interest shall be eligible for entry in the local class. Evidence of residence may be required, i. e. : current driver's license and/or voter registration card .
17. To ensure the safety of exhibitors, livestock and fairgoers, no dogs are allowed on the Fairgrounds – except those used as guide dogs for the disabled or entered in the dog show (one hour prior to and one hour after the dog show, only).
18. By the signature on the entry, each exhibitor agrees to have his or her animals, pens, stalls, and

barn aisle cleaned and in show condition twice daily, before 10:00 am and 5:00 pm each day of the fair. Aisles, pathways, and approaches must be clean at all times. Storage of tack is forbidden in center aisle. Excessive tack and feed will be removed at the exhibitor's expense. In addition to the above, it is required that each livestock exhibitor personally care for his or her animals once each day. There will be no exceptions. Periodic stall checks will be made. Failure to comply will forfeit premiums and exhibit privileges.

19. No ATV's, motorized bikes, scooters, skateboards are permitted on the fairgrounds at any time, without preapproval from Fair Management. If found in violation, motorized vehicles will be removed at the owner's expense.
20. Any foul and/or abusive language, and/or physical abuse used toward any Fair Personnel, Weighmaster, Sale Committee Member, Judge, animal, etc., by an exhibitor, their parent/ guardian, and/or guest will result in immediate expulsion from the Fairgrounds for the duration of the Fair and forfeiture of eligibility in future Gold Country Fairs.
21. Exhibitors, leaders, advisors, and parents found in violation of rules or in practicing unethical or harmful behavior with the fair program shall be penalized by forfeiture of awards and/or privileges as may be deemed appropriate to the circumstances. The Management shall report any such incidents to the Division of Fairs and Expositions in writing and such reports may become the basis for the Gold Country Fair or any other fair to refuse entries.
22. Requests for refunds must be made in writing to the Fair and may be granted only upon the approval of the Fair Board of Directors. No refund of less than (\$5.00) will be given.
  - a. Refunds may be made only because of sickness, accident, or death, cancellation of a class or return of entries for lack of exhibit space.
  - b. Non-selected exhibits in a juried show are not eligible for refunds.
  - c. For animal classes, requests must be made prior to the event. Requests involving the health or soundness of an animal must be accompanied by a veterinarian's certificate.
23. No entry will be accepted when an exhibitor dictates the conditions under which he or she will exhibit.
24. Fair Management reserves the right to interpret the rules and regulations and to settle questions of difference.
- 25. All Livestock, Small Animal and Adult Entries that are not complete by August 1, 2024, will be charged a \$25 penalty fee. The required information and penalty fee MUST be submitted by August 8, 2024, in order to participate at fair.**
26. ALL auction & premium checks not cashed after 90 days are considered null and void. Checks will not be reissued after 90 days. NO EXCEPTIONS.
27. All livestock exhibitors ages 5 and older are required to enter and submit at least one still exhibit project.
28. Exhibitors, Leaders, Advisors and Parents are required to sign an adult code of conduct form. **Anyone** found in violation of rules or in practices deemed unethical or inimical with the Gold Country Fair shall be penalized by forfeiture of premiums awarded and/or privileges as may be deemed appropriate to the circumstances, including ineligibility to participate at future Gold Country Fairs and/or Junior Livestock Auctions.
- 29. This handbook is produced in advance and is subject to any action that may cause revision or curtailment of classes, divisions, awards, premiums, or regulations listed above.**
- 30. The 20<sup>th</sup> District Agricultural Association shall not be responsible for accidents or losses that may occur to any of the exhibitors or exhibits at a show.**

# Adult Code of Conduct

**As the parent, guardian, leader or advisor of an animal exhibitor in the Gold Country Fair:**

I believe my child should demonstrate his or her own ability, knowledge, and skill as a feeder, fitter and show person of a show animal. I understand that adults may NOT participate in my child's duty of washing, grooming, fitting, handling, or showing of his or her animal while at the fair.

**I will ensure that my child follows the competition rules**, and does not use abusive, questionable or unethical techniques in the feeding, caring, fitting, or showing of any animals. I will ensure that my child does not resort to fraudulent, illegal or deceptive practices while fitting or preparing the animal for show and will follow withdrawal protocol.

**I have read and understand all of the rules and regulations found in the Livestock Handbook. I**

**realize that my child is responsible for:**

- The proper care and humane treatment of animals before, during, and after exhibition and sale.
- The production of wholesome food when the exhibit animal is designated for market.

**I will conduct myself at all times to be a credit to my child's organization, chapter, club, school, community, and family.** I will follow proper procedures and chain of command if there is a conflict. **I will not post negative comments or conflict on social media.**

I am aware that **responsible alcohol use** is allowed on the fairgrounds, and I will limit my use of alcohol so that I set a proper example for my child and the children of others around me. I shall ensure that other adults are equally responsible in the use of alcohol around my child. I shall not use any drugs that are considered illegal at the federal, state or local level while on the fairgrounds.

**I understand that direct criticism or interference** with the judge, fair or livestock show management, other exhibitors, breed representatives, or show officials before, during, or after the competitive event is prohibited. In the furtherance of their official duty, all judges, fair and livestock show management, or other show officials shall be treated with courtesy, cooperation, and respect. I will not allow any person connected with my child's project to direct abusive or threatening conduct toward any show official. Protest rules can be found in the State Rules for California fairs at [www.cdffs.ca.gov/fe](http://www.cdffs.ca.gov/fe).

**I understand and agree** that if I, my child, my child's supervisor or leader or any other adult or minor connected with my child's project or animal(s) break the rules, I will accept the final decision of the Gold Country Fair Management regarding the disqualification of my child and or the animal, the loss of prizes, the forfeiture of auction participation, loss of future eligibility, and forfeiture of any monetary award(s).

I understand that my minor child will not stay overnight at the Gold Country Fairgrounds without their parent or guardian present.

**I accept that these entries are subject to the rules and regulations** as published in the official Livestock Handbook. I further declare that all statements made in connection with my child's entries are true.

I will remember that children participate to have fun and that the competition is for the benefit of youth, not adults.

# Market Animal Score Card

## Score Card Details

The Fair Management hire quality judges. Score cards are used as a tool by judges.

However, all judging is subjective. It is that person's opinion that day. Market readiness is determined by the judge.

### **BEEF:**

- Market Ready – Market steers projected to have sufficient fat deposition to meet the marbling specifications for USDA Prime or Choice or Select + quality grades.
- Non-Market Ready – Market steers lacking evidence of sufficient fat deposition to produce a desirable consumer product. A steer projected to grade USDA Select – or lower.

### **SWINE:**

- Market Ready – U.S. Number 1 and Number 2 hogs of average or greater conformation that are acceptable in leanness, muscularity and production traits.
- Non-Market Ready – Any Hog of below average conformation including U.S. Number 3, U.S. Number 4 and utility grade hogs.

### **SHEEP:**

- Market Ready – USDA Prime or Choice quality with 12th rib back fat range of .16 to .35, average or greater conformation and cutability.
- Non-Market Ready – Good or lower quality grade with 12th rib back fat range of <.16 or >.35; under finished lambs grading USDA good or lower, below average conformation or cutability.

### **GOATS:**

- Market Ready – USDA Prime or Choice quality with 12th rib back fat range of .08 to .12 most desirable, .13 to .22 back fat acceptable, average or greater conformation and cutability.
- Non-Market Ready – Good or lower quality grade with 12th rib back fat range of <.08 or >.22; under finished goats grading USDA good or lower, below average conformation or cutability.

We are witnessing many changes and different opinions in the beef industry today as to what constitutes the ideal market animal. Variations in yields of retail cuts among beef carcasses are accounted for mainly by the amount of fat that must be trimmed in preparing the cuts, and thickness and fullness of the muscling.

- Heifers 18 months and over, must be bred. Bred heifers entered in this division, must have a mandatory pregnancy confirmation by a veterinarian within 30 days prior to arrival at the fairgrounds, at the exhibitor's expense. Proof of pregnancy must be turned in to the Livestock Office on check-in day.

- Exhibitor will furnish containers for food and water, as well as own bird's food, and will be responsible for the care and well-being of his or her poultry exhibit.
- Primary members must enter only Primary Divisions. Entries receive participation award ribbons and are not eligible for Champions.
- All birds will be checked for mites prior to cooping.
- Refer to local and state rules that apply to these divisions.

- All birds will be inspected by certified poultry health inspectors prior to cooping-in.

- One (1) Market Egg will be on display in the Small Animal Barn after judging if eggs are available.
- Eggs will be stored after judging and returned to the exhibitors on Saturday for the Auction. While not required, market eggs that qualify for the auction can be packaged with a basket of items complimenting the eggs.

### RULES:

- Only two market entries for the Small Animal Departments will be accepted, only one entry is eligible for auction unless exhibitor has a Grand and Reserve Grand Champion market animal.
- A meat pen shall consist of three rabbits. Meat pen rabbits may be crossbred, but the primary breed must be listed on the entry form (i.e. California cross).
- Single Fryer Rabbit, 3.0 pounds to 5.0 pound weight limit.
- Rabbits will be weighed in on Wednesday September 4, 2024. Rabbits cannot be over 10 weeks of age. Meat pens will be judged according to Meat, Condition, and Uniformity.
- Exhibitors must be present during judging.
- Receipt must be presented with proof of age and ownership. If rabbits are bred from exhibitor's own stock, a written verification must be presented, signed by exhibitor, parent, and 4-H Rabbit Leader or FFA Instructor.
- Two (2) pens may be weighed in and shown BUT ONLY ONE PEN will be eligible for the auction, unless exhibitor has a Grand and Reserve Grand Champion market animal.
- If exhibitor is weighing in TWO PENS OF RABBITS, LIST ALL SETS OF EAR NUMBERS on entry form.
- After judging of division, JUDGE will place eligible pens of meat rabbits in sale order for Auction.
- Primary members are not eligible for market classes.
- Meat type is the most important factor in judging these pens. The hindquarters are most important, loin second, and forequarters are third in importance. All fryers in a pen must be in prime condition. The fryers must be firm and solid. Uniformity must be present in weight, size, appearance, condition, meat type and should be as similar in all respects as possible.
- Each entry must be of the same breed and color. Mixed breeds are allowed, but all three rabbits in the Meat Pen must be a mixed breed.

- 01 Pen of Three Market Rabbits - the minimum weight is to be 3.0 to 5.0 pounds per rabbit. The maximum total weight is not to exceed 15 total pounds per pen, not over 10 weeks, all breeds judged together.

- Animals will not be released until exhibitor has dumped and hosed out trays and feeders, to the satisfaction of Fair Management.
- Rabbits that are disqualified because of permanent defects, deformities or blemishes, and those absent at the time of judging do not count when computing the number of exhibitors in the class.
- A Judge may eliminate (excuse) a rabbit from competition because of temporary or curable defects, but the rabbit should be counted as an entry.
- Ear number, birth date and sex must be on entry form.
- The Youth Rabbit show can be sanctioned as an official A.R.B.A. Youth Sanctioned Show. Rules, definitions and judging procedures as prescribed in the latest edition of the Guide Book and Standard of the American Rabbit Breeder's Association, Inc., shall apply to all district and county fair rabbit shows, provided they do not conflict with any of the rules and regulations prescribed by the Department of Food and Agriculture.
- Every exhibitor is personally responsible for the care of their rabbit(s), including feeding, watering, and cleaning of cages), for all four days of the fair, and to see

that their cage has feed and water containers. If this is not done, exhibitor may lose premiums won and the right to sell at auction.

- Only breeds listed in the Standard of American Rabbit Breeder's Association Inc., are eligible.
- Duplication of identification numbers are acceptable on animals of different breeds.
- Primary members must enter only Primary Divisions. Entries receive participation award ribbons and are not eligible for Champions. Primary exhibitors are limited to one (1) animal per species.
- Refer to Local and State Rules that apply to these divisions.

## NOTE:

Breed and variety of each animal must be listed on entry form.

# Showmanship

## **RULES:**

- ALL SHOWMANSHIP MUST BE PRE-ENTERED. ENTRIES CLOSE THURSDAY, AUGUST 1, 2024.
- Only animals owned, shown and entered by junior exhibitors in the junior department are eligible for entry by the owner in the showmanship classes.
- The Showmanship Schedule will go according to Class Order: FFA Senior, FFA Novice, 4-H Senior, 4-H Junior, 4-H Novice.
- Independent Exhibitors WILL enter either a 4-H Class or FFA class according to their age. All fourth through eighth grade independent exhibitors enter 4-H classes based on their abilities (Novice, Junior or Senior). All High School Independent exhibitors enter FFA classes based on their abilities (Novice or Senior).
- Only animals owned, groomed, and shown by the exhibitor in the regular classes are eligible.
- Exhibitors are required to wear the official show uniform.
- Only animals owned, shown, and entered by junior exhibitors in the junior department are eligible for entry by the owner in the showmanship classes.

## **JUDGING:**

- The Judges will help members improve showmanship techniques while judging and will demonstrate proper procedures.
- A large class may be divided into smaller groups for ease of handling and judging and to provide maximum benefits of this learning experience for the Novice and Junior Showman.
- A first-place award indicates that the showman is proficient for his/her age level and experience and should move to a more advanced class.

## **Definition of Terms:**

- **4-H Novice** – 1st year showing this species, regardless of prior organizational experience. Prior participation in the Primary Showmanship is not considered prior showmanship experience and will not affect a member's eligibility to compete as a novice.
- **4-H Junior** – Exhibitors ages 9 – 13 having prior showmanship experience, in that species, if you place 1st at a county fair in this county in this specie you must move up to Senior Showmanship
- **FFA Novice** – 1st year showing this species regardless of prior organizational affiliation.
- **4-H/FFA Senior** – Exhibitors ages 14 – 19 having prior showmanship experience, in that species, at a California Fair and previous winner of the Placer County Fair Junior Master Showmanship.

- The exhibitor with the highest total score will receive the Master Showmanship Award.
- Judges must be adults.
- Master showmanship winners may not show their own animal.
- Small Animal Round Robin will be on Sunday, September 8 at 11:00 AM in Show Ring #1. All Exhibitors must check in at 10:30 AM at Show Ring

## Large Animal Master Showmanship
